## **Tea With a Pony Terms and Conditions**

- 1. This is an alternative activity for those participants and their carers/family members who can't ride due to current restrictions. We welcome any participants who are living with any disabilities and their carers/family members to spend some time with a pony.
- 2. A booking form must be completed prior to confirm of your booking and a RDA 'participant' form completed for each participant.
- 3. We have a maximum capacity of 3 people per group (1 participant and 2 carers/family members).
- 4. By nature, horses are unpredictable it is important to recognise that this activity involves risk and the participant and their carer/family member must follow all advice given by staff and volunteers. A safety briefing will take place at the start of the session.
- 5. Payment of £5.00 per individual participant and £2.50 refreshment charge per carer/family member.
- 6. We may need to cancel the session due to poor weather or other unforeseen circumstances. If so, we will not charge for the session and will either refunded or reschedule the session.
- 7. Cancellation by the booker may still be charged by the Unicorn Centre if less than 24 hours' notice is given.
- 8. The Unicorn Centre reserve the right to refuse or stop the session at any time.
- 9. We welcome an additional carer/family member should they wish to accompany the participant, and there is a charge of £2.50 per head for each additional carer/family member having refreshments.
